 After hearing, the court determines and orders as follows:

**It is hereby ordered that the defendant shall:**

- A.  Be released on personal recognizance.  
B.  Be released on an unsecured appearance bond in the amount of \$ \_\_\_\_\_.  
C.  Be detained for not more than 72 hours to allow for filing of a probation violation.

 Reasonably assure the appearance of the defendant, and/or  
 Reasonably assure that the defendant will not commit an offense while on release  
E.  Be placed in preventive detention pursuant to RSA 597:2, III(a) based on clear and convincing evidence that the defendant's release will endanger the safety of the defendant or of the public.

**The defendant is subject to the following additional conditions:**

Defendant shall not commit a federal, state or local crime while on release, must appear at all court proceedings as ordered and must advise the court in writing of all changes of address within 24 hours.

**Supplemental Order for Strafford County Community Corrections  
Pretrial Services**

A.  The defendant shall receive pretrial services through Strafford County Community Corrections ("SCCC").

B.  The defendant shall be evaluated by SCCC. If accepted by SCCC, bail shall convert from cash or corporate surety to an unsecured appearance bond in the same amount and the defendant shall receive SCCC pretrial services. Defendant shall not be released until the unsecured appearance bond form is completed.

If SCCC pretrial support services are ordered, those services shall be provided according to such conditions as SCCC deems appropriate.

In addition, the following conditions shall apply:

1.  The defendant shall obtain a Substance Use Disorder treatment assessment and shall comply with all resulting recommendations.
2.  The defendant shall obtain a Mental Health treatment assessment and shall comply with all resulting recommendations.
3.  Submit to random drug and/or alcohol tests.
4.  Sobriety.
5.  GPS.

If defendant violates any terms of this bail order, or any terms of SCCC pretrial services:

bail shall convert to cash only in the amount of the unsecured appearance bond, with a bail review hearing to be held within 72 hours (Saturday, Sunday and holidays excepted); or

the defendant shall be detained, with a bail review hearing to be held within 72 hours (Saturday, Sunday and holidays excepted).
