STATE'S MOTION TO HAVE WEBEX AVAILABLE FOR OBSERVERS

NOW COMES the State of New Hampshire, by and through its attorney, the Office of the Attorney General, and respectfully requests that this Honorable Court allow members of the victim's family to attend the July 10, 2025, motions hearing via Webex. In support of its request, the State says as follows:

1. The defendant is currently charged with first-degree murder, and other charges related to the murder of Caitlyn Naffziger (DOB: 3/201992) which occurred on February 29, 2024.
2. A hearing is scheduled for July 10, 2025, at 10:00 A.M., in the Coös County Superior Court, at which time, the Court will hear pending motions.
3. Several family members of Ms. Naffziger are located outside of the State of New Hampshire and would like to attend the motions hearing.
4. As such, the State is requesting that the Webex system be activated for the purpose of allowing remote attendance for persons who are unable to attend the hearing in person.
5. Counsel for the defendant, through Attorney Hanna Kinne, assents to the State's Motion.

WHEREFORE, the State respectfully requests that this Honorable Court:

- A. Grant the State's Motion; and,
- B. Allow Family Members of the parties to attend the July 10, 2025, motions hearing over Webex; and,
- C. Grant such further relief as may be just and proper.
