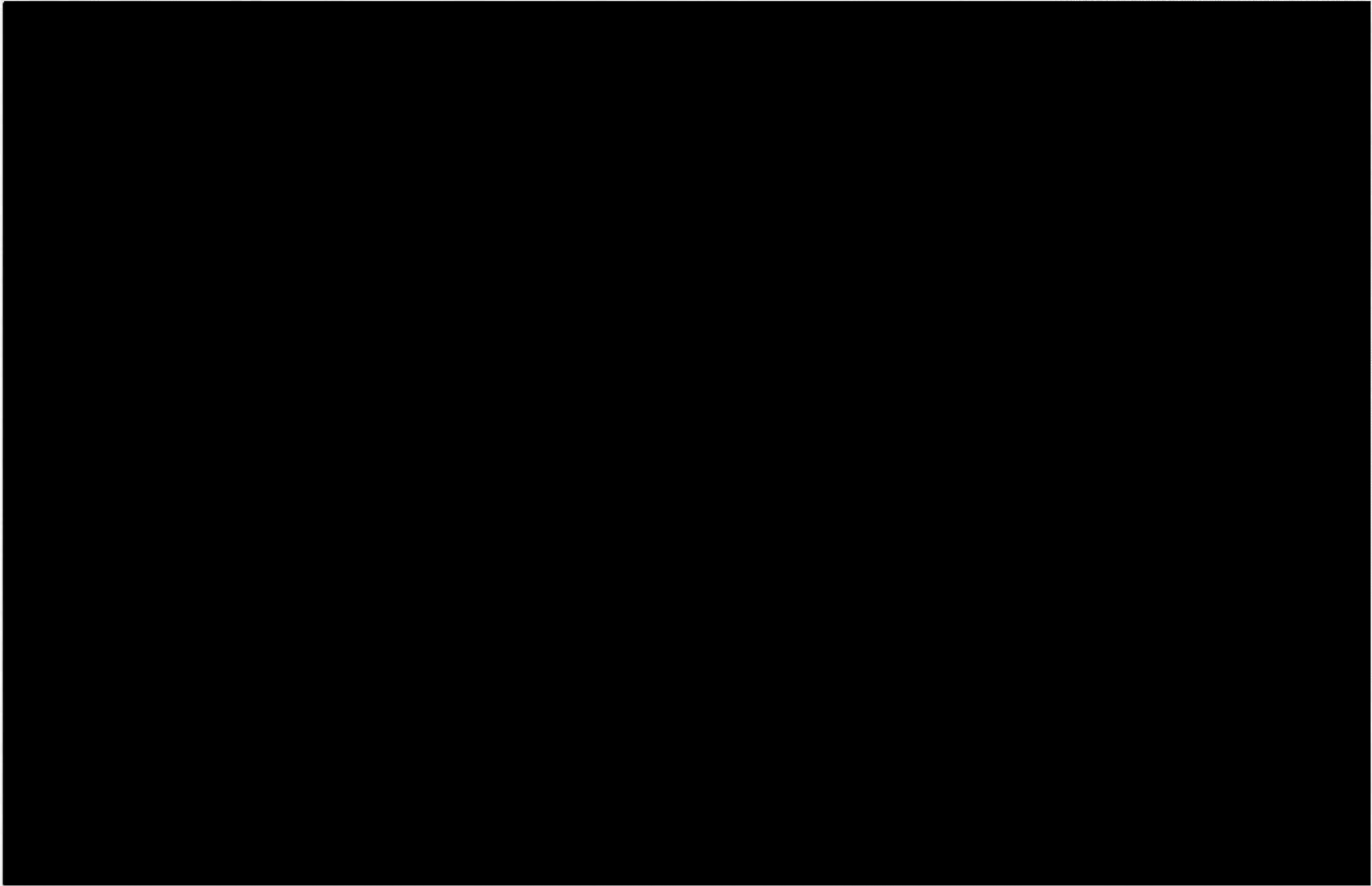

On March 11, 2022 Detective McGee, Deputy Tufts, and I (Det. Dunleavy) went to the Hillsborough County Department of Corrections to interview an involved party in this case. The person was identified as:

We were escorted into a private interview room to speak with Montgomery about the above listed case. The interview began at 1527 hours.

The following is a synopsis of the interview intended to summarize the content of what was discussed. It is not verbatim nor is the information necessarily in the exact chronological order in which it was given. An audio recording of the interview was completed and a DVD-R copy of that recording was secured into evidence marked as item JD2.

I informed her I was not here to talk about the Harmony Montgomery case and was here to discuss another case. I informed her she was not under arrest for the case I was here to discuss but was still going to read her Miranda. I had Kayla read Miranda verbatim and initial line 1-5 indicating she understood each line. Kayla then indicated she understood her rights and would waive her rights and answer questions. Kayla signed the form and Deputy Tufts and I signed as witnesses. The Miranda form was later scanned into the case file. I explained to her that I was here to discuss a gun case and was serving her with a Grand Jury subpoena. I briefly explained the process of Grand Jury to her before starting the interview.

I asked her if she was aware of what we were talking about. She stated her lawyer had called her stating someone reached out to him asking if she wanted to talk about the gun case. Kayla stated she did not want to but knew what he was talking about. Kayla stated she remembers the gun situation when it happened with Chris and Kim. She recalls Kim was home passed out and Adam went to meet her and her door was open and she was sleeping. Adam woke her up and stuff was missing from what she knows. I asked her if she knows who ended up with the guns and she stated she did not know. I asked her if she knows if the guns were recovered and she stated she did not know. I asked her if anyone had suspicions about who took them and she stated people thought it was Adam, "ish" and "Manny". Kayla stated "ish" is a drug dealer she met through Kim. She identified him as "Ish Garcia". I asked her who "Manny" is and she stated he is in that group of people. Kayla stated she did not think his real name was Manny and that he was Spanish with a beard or facial hair, long hair, and in his twenties. Kayla stated Kim let a lot of people in the home and use her car when her husband wasn't home. Kayla stated Kim had a black Honda and let "ish" use it a lot. Kayla stated Kim blamed "ish and Manny". I asked her who blamed Adam and she stated Kim, "ish, and Manny". They all stated that Adam could have done it because he was at the house.

I asked her who identified the guns being missing and she stated she thinks Chris but it could have been Kim. I asked her what she thinks about the potential that Adam took them and she stated she didn't know but if he did she would have seen something and stated she didn't see anything like that. I asked her about times she had seen guns at the house with Adam and she stated never. I stated to her people had stated they had seen them at the house and she stated, not with her around. I told her that other people had said otherwise and told her that just being around her doesn't necessarily mean she is in trouble. I told her no one has told her she stole them but knows she was there. Kayla stated, "no". I asked her if there was any reason someone would lie and she stated so they wouldn't get in trouble or to save someone else from getting into trouble.

I asked her if she had any conversations with anyone else about this gun theft and she stated no, just her lawyer. I asked her what she said and she stated what she told me. I asked her if she had any concern for getting in trouble for it and she said no. I asked her what the reason she spoke to her lawyer about it and she stated her lawyer asked her about it this week. I asked her about bringing it up prior to this and she stated no and then stated Tarah had brought up that Adam was a suspect or under investigation with something with guns. I asked her what she would say if I told her I know she had a conversation with Chris about it prior to speaking to her attorney about it and she stated "yeah". Kayla stated she didn't talk to him about it and that a Marshall showed up at his work. Chris stated a Marshall showed up at his work asking him about guns. I explained to her she said to Chris that she had spoken to her attorney about it and that she was fine and she stated no, that is not what she said. I stated to her that I had heard it on the phone call. Kayla stated she spoke to her attorney about the conversation with Chris. She stated she wasn't saying she was fine meaning she is not doing anything with the guns or getting charged with anything to do with the guns. I asked her if she has any reason to lie

about it or that she thinks she is going to get in trouble for something he did and she said no. I asked her if she would be surprised to learn that Adam stole them and she stated, "I don't know". I asked her with one job and his drug habit would it make sense that he would do whatever possible for money and she stated, "probably". I asked her who else had been brought up involving the gun case and she stated that was it.

Det. McGee asked Kayla about showing up to the house when the door was open and Kayla stated she wasn't there it was Adam. McGee asked her what Adam said about it. Kayla stated that the dog was in the living room and Kim was passed out and Adam woke her up. He asked if Adam said what their conversation was after she woke up and she said no. Kayla was asked why Kim would think it was Adam if they were close. Kayla stated everyone was putting the blame on Adam and everyone was blaming everyone. Kayla stated Kim was the one who blamed him and never heard Manny or Ish blame Adam. According to Kim she stated that Ish and Manny were saying it was Adam. Kayla was asked if she ever saw Manny or Ish at Kim's house and she stated she never really went over her house. Kayla stated she went twice because Kim babysat her son. Kayla was asked how often she saw Kim and she stated she saw her every day at work. Kayla was asked after everything if the relationship with Adam and Kim was like and she stated it was fine. I asked her if she ever asked Adam about it and she stated she did but didn't expand. Kayla confirmed that Adam's relationship with Manny and Ish revolved around drugs and that they all stopped talking after this. Kayla stated she would see them every couple days prior to the incident. Kayla stated the last she heard about the guns before this was in 2019. Kayla stated Kim didn't believe it was Adam.

Det. McGee asked if Kim was involved and she stated she doesn't know. Kayla stated that Kim would let people in and out of the house and allowed Ish and Manny to sell drugs from the house. Kayla was asked if the guns were locked up and she stated she did not know. Kayla was asked about Adam's interest in guns and talking about them and she stated he only told her about the shooting he was arrested for.

Montgomery became emotional and stated she has been crying a lot since yesterday. She stated she had court yesterday for her kids and I asked her what happened. I asked her if she talked to Adam and she stated, "kind of not really". Kayla stated they were separate but sitting near each other. Kayla stated she was upset in general and was filing for a divorce. Kayla was crying and stated, "I think i'm done talking right now". I informed her she knew how to contact us if she wanted to talk further.

The interview ended at 1552 hours.
