PLEASE TAKE NOTICE that the civil action being filed by John Doe #794, Case No. 218-2023-CV-00647, in Rockingham Superior Court is related to Case No. 217-2020-CV-00026 (the “Meehan Case”) pending in this Court, within the meaning of this Court’s Order Designating 2020-CV-26 As the Lead Case for Filing Purposes.
