PLAINTIFFS' ASSENTED-TO MOTION TO EXTEND REPLY DEADLINE

(For all Plaintiffs represented by Rilee & Associates, P.L.L.C. and Nixon Peabody LLP)

Plaintiffs¹ hereby move the Court to extend Plaintiffs' April 6, 2023 deadline to file a reply in support of their Motion to Compel Production of Documents and Amendment of Discovery Responses ("Motion to Compel"). In support thereof, Plaintiffs state as follows:

1. Plaintiffs filed their Motion to Compel on February 15, 2023.
2. With Plaintiffs' assent, State Defendants' deadline to respond to the Motion to Compel was extended 30 days to March 27, 2023, and State Defendants filed their Objection to the Motion to Compel on that date.
3. Currently, Plaintiffs' Reply deadline is April 6, 2023. Plaintiffs require additional time to finalize their Reply.
4. For the reasons outlined herein, Plaintiffs therefore request a 7-day extension of the reply deadline—or, until **April 13, 2023**.

5. Plaintiffs have consulted with counsel for State Defendants who assent to this requested extension of Plaintiff's Reply deadline.
6. This extension will not result in any prejudice to the other parties or the Court, and will not result in the continuance of any other court-ordered deadline.

WHEREFORE, Plaintiffs respectfully request that this Court:

- A. Grant Plaintiffs' Assented-to request to extend the reply deadline to April 13, 2023;
and
- B. Grant any other relief as is just and fair.
