**ASSENTED-TO STATE'S REVISED STRUCTURING PROPOSAL**

NOW COMES the State of New Hampshire, by and through its attorneys, the Office of the Attorney General, and respectfully submits the following assented-to proposal for dates and deadlines for trial and pretrial matters in the above-captioned case. Counsel for the defendant, through Attorney Lauren Prusiner, is in agreement to the proposed deadlines below:

1. Deadline for State's deposition of defense experts: July 18, 2025
2. Pretrial evidentiary motions, including *motions in limine*: July 22, 2025<sup>1</sup>
3. State rebuttal expert report: August 8, 2025

*The below deadlines have already been ordered by the Court:*

4. State's anticipated trial witness list: August 8, 2025
5. Defendant's anticipated trial witness list: August 15, 2025
6. Proposed Jury Instructions: Final Pretrial
7. Final Pretrial: August 18, 2025
8. Non-substantive Procedural Motions (*sequestration, etc.*): August 29, 2025

Further, the parties reserve the right to file additional evidentiary motions based on any supplemental discovery that is received. The parties to provide witness lists 7 days before any scheduled evidentiary hearing on such motions.
