**ASSENTED-TO MOTION TO EXTEND FILING DEADLINE FOR
PLAINTIFFS' MOTION TO RECONSIDER**

Plaintiffs, by and through counsel, hereby submit this assented-to motion for extension of time to file a motion to reconsider the Court's Order denying Plaintiff's motion for preliminary injunction. In support of this motion, Plaintiffs state as follows:

1. On August 20 and 27, 2025, the Court held a hearing on the merits of Plaintiffs' preliminary injunction motion. This Court issued an order denying Plaintiffs' motion on September 12, 2025.
2. Plaintiffs wish to file a motion for reconsideration of the Court's Order. Pursuant to Superior Court Civil Rule 12(e), the current deadline for such a motion is September 22, 2025.
3. Due to heavy workload and competing priorities, Plaintiffs' counsel require additional time to complete the motion.
4. Plaintiffs' counsel conferred with counsel for the State who indicated they agree to Plaintiffs' request for a ten-day extension.

WHEREFORE, Plaintiffs respectfully request this Honorable Court:

- A. Extend their deadline to file a motion for reconsideration of the Court's Order on Plaintiffs' Motion for Preliminary Injunction by ten (10) days, to **October 2, 2025**; and
- B. Grant such other and further relief as justice may require.
