**STATE'S ASSENTED-TO MOTION TO CANCEL STATUS HEARING SET FOR
MONDAY, APRIL 26, 2021**

NOW COMES the State of New Hampshire, by and through its attorneys, the Office of the Attorney General, and respectfully requests that the Court cancel the status hearing set for Monday April 26, 2021, as assented to by counsel for the defendant, and in support thereof states as follows:

1. The defendant has been indicted for two counts of Second Degree Murder.
2. On March 24, 2021, the Court issued an order on the Defendant's Motion to Compel "Outstanding" Discovery, namely, the discovery file in State v. Holloway, Docket No. 226-2019-CR-00814 ("the Holloway file"). In its decision, the Court ordered the State to obtain the Holloway file from the Hillsborough County Attorney's Office, and review the material therein. At the time, the Court scheduled a deadline of Friday, April 23, 2021 for production of any favorable or exculpatory evidence contained in the file to the defendant, and scheduled a status conference to ensure said production was done for April 26, 2021.
3. On April 16, 2021, the Court amended the deadline to May 7, 2021. This amendment removes the reason for the Status conference on the morning of Monday April 26, 2021.

4. The State conferred with counsel for the Defendant, who agreed that there no longer remains any reason for the status conference on the morning of Monday April 26, 2021.

WHEREFORE, the State of New Hampshire respectfully requests that this Honorable Court:

(A) Cancel the Status Conference scheduled for the morning of Monday, April 26, 2021;
and

(B) Grant such further relief as may be deemed just and proper.




