SUMMONS

This matter having come for hearing this _____ day of February/March, 2024, pursuant to an order to show cause why Kathie Bradstreet (DOB:04/24/1965) residing at 208 Arega Street, Sebastian, Florida, should be summoned pursuant to certificate by service upon the aforementioned witness, having had the opportunity to appear and testify, and the Court having considered the certificate of the Honorable Mark E. Howard, Superior Court Justice for Strafford County, State of New Hampshire, a copy of which certificate is attached hereto, and the affidavit of Attorney Brian Greklek-McKeon, and having considered the testimony of the aforementioned witness, and having been otherwise fully advised, the Court finds as follows:

1. That Kathie Bradstreet is a material and necessary witness in the upcoming trial of State of New Hampshire v. Timothy Verrill, Strafford County Superior Court Docket No. 219-2017-CR-00072.
2. That it will not cause undue hardship to the aforementioned material witness to attend and testify in the foregoing proceeding.
3. That the State of New Hampshire will arrange for travel expenses and per diem expenses for the witness's appearance in New Hampshire in compliance with N.H. RSA 613:3.

4. That the State of New Hampshire, by its laws, makes provision for commanding persons with that State to attend and testify in criminal proceedings outside the State of New Hampshire, and makes provision for the summoning of witnesses within the State of New Hampshire to testify in other States, such as the State of Florida.

5. That the laws of the State of New Hampshire give the witness protection from arrest or service of process, criminal or civil, in connection with matters which arose before the entrance into the State pursuant to this summons, as set forth in New Hampshire RSA 613, a copy of which is attached.

6. Now therefore, it is hereby ordered that Kathie Bradstreet is summoned and commanded to attend and remain available to testify in the trial of State of New Hampshire v. Timothy Verrill, Strafford County Superior Court Docket No. 219-2017-CR-00072, to be held at the Strafford County Superior Court, in Dover, New Hampshire, on March 20 and/or March 21, 2023.
