Now Comes the Defendant, Dale E. Holloway Jr., Pro Se, pursuant to NH R. CRIM. PROC., Rule 17 (b), under both state and federal constitutions that provide Rights of Accused, who respectfully requests that this Honorable Court allows or grants an issuance of Subpoena for Third party Records from ("GTL") Global Tel*Link Corporation and ("Viapath") Technologies for the following =

Proc.~~ Rule 12(b)(1) of NH Super. Court Rules for open Discovery, and has failed to obtain the Exculpatory Evidence Admissible at Trial, Most Favorable to Mr. Holloway. 
