**STATE'S MOTION FOR A COURT ORDER FOR RSA 604-A FUNDS TO REIMBURSE
A HILLSBOROUGH COUNTY EMPLOYEE FOR THE PURCHASE OF A BLU RAY
PLAYER FOR THE DEFENDANT, DALE HOLLOWAY**

NOW COMES the State of New Hampshire, by and through the Hillsborough County Attorney's Office, and requests that this Court order the Provision of RSA 604-A:6 Funds for the reimbursement of a Hillsborough County employee who purchased a Blu Ray player for the defendant, Dale Holloway, stating in support as follows:

1. Some of the discs provided to the defendant, Dale Holloway as a part of discovery, are Blu Ray discs that can be accessed only by using a Blu Ray player.
2. Apparently, Mr. Holloway does not have access to a Blu Ray player at the New Hampshire State Prison, which is where he is currently incarcerated.
3. A Hillsborough County employee purchased a Blu Ray player, which is being delivered today to Mr. Holloway at the State Prison. A copy of the receipt documenting this purchase is attached to this pleading.
4. The State requests that the Court order the provision of RSA 604-A:6 funds to reimburse a Hillsborough County employee who purchased the Blu Ray player as it is not the State's responsibility and/or obligation to cover the costs of the defendant's discovery processes.
