**ASSENTED-TO MOTION TO CONTINUE DISPOSITIONAL CONFERENCE  
AND TO SET ESTABLISH DEADLINE FOR SUBMISSION OF JOINT  
PROPOSED STRUCTURING ORDER**

Defendant Danielle Dauphinais hereby moves, with the ASSENT of the State, to continue the dispositional conference, currently scheduled for June 28, 2022, and to set a deadline for submission of a joint proposed structuring order.

Dauphinais relies upon the following:

1. Dauphinais is charged with first degree murder, among other things.
2. A dispositional conference is scheduled for June 28, 2022.
3. Undersigned counsel will be out of state on vacation from June 24, 2022 through July 8, 2022.
4. Given the serious nature of the allegations in this case, and the voluminous discovery which must be reviewed by counsel, Dauphinais proposes that, in lieu of a dispositional conference, the Court establish a deadline of August 31, 2022 for the submission of a joint proposed structuring order, addressing, among

other things, deadlines for discovery disclosure, expert disclosure, discovery motions, evidentiary motions, and a plea deadline.
