Second-degree murder, knowing – Capped Plea of 55 to Life.

In addition to whatever sentence the Court imposes on the charge of second-degree murder – the defendant would also plead to Tampering with Witnesses (x2) . The defendant would agree that the sentence on those charges would be 3.5 – 7 years (concurrent with each other) and would be consecutive to the sentence for the second-degree murder.

Additional conditions:

Waiver of Earned Time Credit

Joint liability for any funeral or counseling expenses

May not profit in any manner from these offenses including the murder, life of Elijah Lewis or flight from the investigation. Specifically, she shall not accept any payment, enter into any contract, or sell rights regarding any book, film, television show, radio show, website, podcast or any other writing, recording, broadcast, or internet posting relating to the offenses, the murder or Elijah Lewis.
